

Highlights

- 1H24 revenue and gross profit rose strongly to Rp2.2 trillion and Rp71.4 billion on the back of aggressive territory expansion
- This leads to a short-term pinch at the operating level, but expect turnaround in 2025 onwards
- 1H24 net loss at Rp247.1 billion, dampened by the unrealized loss on other investments.

1H24 revenue and gross profit rose strongly to Rp2.2 trillion and Rp71.4 billion respectively on the back of aggressive territory expansion

PT Distribusi Voucher Nusantara Tbk ("DIVA" or "the Company") managed to record satisfying revenue growth of 16.4% YoY, from Rp1.9 trillion in 1H23 to Rp2.2 trillion in 1H24. This was mainly supported by Company's successful expansion into Sumatera (Jambi, Bengkulu, Lahat and Lampung) and Central Java (Semarang, Pati, Demak and Pekalongan) markets. Impact of this market expansion, DIVA managed to garner new SME members of 16,162 outlets in the digital product business segment.

Other segments that also showed good performance are digital financial service and other ecosystem generated revenue. Revenue from digital financial service segment jumped by 92.4% YoY, from Rp153.1 billion in 1H23 to Rp294.8 billion in 1H24, mainly underpinned by increasing transactions in the toll roads as well as public bus stations (Trans Jakarta). Meanwhile, revenue from other ecosystem generated revenue segment leapt by 13 folds YoY, from Rp865 million in 1H23 to Rp11.5 billion in 1H24, mainly driven by strong EV bike demand in DIVA group's SME ecosystem.

On the profitability side, the Company has successfully improved its gross margin, from 2.9% in 1H23 to 3.3% in 1H24. Result of this, gross profit increased at an accelerated pace, up by 31.5% YoY, from Rp54.3 billion in 1H23 to Rp71.4 billion in 1H24.

This leads to a short-term pinch at the operating level, but expect turnaround in 2025 onwards.

In the initial year, our aggressive area expansion initiative causes a push at the operating expense level, rising by 38.6% YoY, from Rp46.9 billion in 1H23 to Rp65.0 billion in 1H24. Hence, operating profit declined by 14.1% YoY, from Rp7.4 billion in 1H23 to Rp6.3 billion in 1H24, while EBITDA down by 4.2% YoY, from 15.5 billion in 1H23 to Rp14.8 billion in 1H24. We expect to see greater contribution of this expansion in the coming years, starting 2025.

1H24 net loss at Rp247.1 billion, dampened by the unrealized loss on other investments

The Company recorded unrealized loss on other investments of Rp246.8 billion in 1H24, against Rp525.2 billion in 1H23. Trickle-down effect of this is the Company recorded net loss of Rp247.1 billion in 1H24 and Rp521.3 billion in 1H23. Worth noting that the main purpose of DIVA making this investment is to strengthen its business fundamentals, can be in the form of market access, connections, business know-how and/or technical expertise.
